Re: **Implementation of Campus Traffic Management and Regulations**

---

Warm Greetings in St. La Salle!

De La Salle University – Dasmariñas remains committed to ensuring the safety, security, and convenience of all individuals on campus. In our ongoing efforts to enhance traffic management, optimize vehicle flow, and foster a safer pedestrian environment, the following traffic regulations will be implemented within the campus premises, effective **June 9, 2025**.

- Gate 4 is for vehicle entry only, while Gate 2 is exclusively for vehicle exit. Gate 3 handles both vehicle entry and exit. Pedestrians should use Gates 1 and 3 only.
- To facilitate two-way traffic flow on Acacia Avenue, parking will no longer be permitted along its stretch.
- Dropping off or picking up passengers is strictly prohibited on Acacia Avenue. Pedestrians are also advised to avoid walking along Acacia Avenue.
- The route from the CBA building towards POLCA remains one-way only, parking will no longer be permitted along its stretch..
- Lake Avenue is primarily for pedestrians. Vehicle traffic and parking are generally prohibited, with a few exceptions.
- Vehicles must only park in clearly marked designated parking slots. Parking is on a first-come-first-serve basis.
  - ADG, JFH, PCH, COS and Chapel parking areas are reserved exclusively for university employees.
  - Parking areas located between Gate 1 and Gate 4, and between Gate 1 and Gate 2, are specifically for students and visitors.
  - GMH, CBA and ULS parking areas are reserved exclusively for university employees.
  - POLCA, GDO, OVAL and back of Security Office are specifically for students and visitors.
  - Designated motorcycle parking areas are located near Gate 1, beside ICTC, near the Security Office, and in the ULS parking zone.
