



# **WEARING OF ID AND UNIVERSITY DRESS CODE POLICY**



Since the Student Handbook is scheduled for revision, it is timely and strategic that respective committees start drafting their proposed revisions to the stipulations mentioned in this memo.

The effectivity of the existing Student Handbook covers the School Year 2022-2023. Therefore, a committee is currently being formed in preparation for the revision of the Student Handbook.

This means that the said committee sets up a venue where students can raise their proposed revisions to the current provisions contained the Student Handbook.

In the meantime, the current provisions contained in the existing Student Handbook will be observed.



# STUDENT IDENTIFICATION

ID CARD\* should be visibly worn using lanyard inside the campus at all times.

\*Please be reminded that as stated in Section 19.1.4, Improper/non-wearing of school ID is considered a minor offense. In lieu of the pending issuance of ID cards (for Freshmen batches from SY 2020 to date), the official (green) Certificate of Registration (COR) with OUR\* stamp shall serve as official student identification in the meantime.

\*As per OUR memo dated October 12, official COR is ready for claiming through respective department secretaries.

## **IMPROPER CIVILIAN CLOTHES AND OTHER DRESS CODE POLICY VIOLATIONS (as stated in Section 19\*)**

\*Please note that students considered to be wearing improper civilian clothes are allowed to enter the University. However, corresponding notice of offense is issued to the concerned student based on Dress Code Policy Violations Section 19.

- jeans that are ripped more than three (3) inches above the knee and with visible skin
- shorts (business style) that are more than three (3) inches above the knee
  - spaghetti straps, racer back, tube, unprescribed sleeveless blouses
  - blouses and dresses with plunging neckline/backless
  - midriffs, hanging blouses, off shoulder blouses and dresses





## **IMPROPER CIVILIAN CLOTHES AND OTHER DRESS CODE POLICY**

### **VIOLATIONS (as stated in Section 19\*)**

- skirts/dresses more than two (2) inches above the knee
- overly tight clothes for male and female (including leggings and jeggings)
  - haltered blouses/dresses and crop tops
  - see-through clothes without proper inner garments
- t-shirts, blouses, and dresses with offensive prints/statements
  - cross dressing
- all kinds of slippers (except during heavy rains) • body piercing (both for males and females) and more than a pair of earrings for females
- tattoos particularly concerning CCJE, CEAT, CTHM and COEd students due to the nature of their courses.
