

DLSU-D STARS 2 Rules & Mechanics

1. Open to all Filipino citizens or legal residents of the Philippines aged 18 and over. Tickets must be filled out in the name of a single individual.
2. A maximum of 10,000 tickets will be available for purchase (per tier: High School, College and Graduate School). If fewer than 10% of tickets are sold per tier by the date of the virtual raffle draw (on or before September 1, 2021), the DLSU-D STARS 2 Committee will utilize a 50/50 drawing scheme where one (1) winner will be selected to receive 50% of total raffle sales to date per tier.
3. There is no limit to the number of tickets an individual may purchase.
4. The winner will be notified by phone and email according to the contact information provided to DLSU-D.
5. In the event a winner cannot be contacted and/or fails to respond within 48 hours of notification an alternate winner will be selected by DLSU-D.
6. The winner will have five (5) business days to accept the prize in writing. If the winner cannot accept the prize within five (5) business days or fails to otherwise qualify for the prize, the winner designee will forfeit any rights to the prize and the same will be awarded to an alternate winner.
7. Prizes are transferrable but are not convertible to cash. For it to be utilized, DLSU-D Admissions procedures must be followed.
8. By receipt of any prize, winner agrees to release and hold harmless DLSU-D, their respective subsidiaries, and employees from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the raffle or receipt or use or misuse of any prize.
9. Except where prohibited, participation in the raffle constitutes winner's consent to DLSU-D's use of winner's name, likeness, photograph, voice, opinions for promotional purposes in any media, without further payment or consideration.
10. DLSU-D reserves the right to cancel, suspend and/or modify the raffle, or any part of it, if any fraud, technical failures or any other factor beyond DLSU-D's reasonable control impairs the integrity or proper functioning of the raffle, as determined by DLSU-D in its sole discretion. DLSU-D reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the raffle process or to be acting in violation of these Official Rules and Regulations. Any attempt by any person to deliberately undermine the legitimate operation of the raffle may be a violation of criminal and civil law, and should such an attempt be made, DLSU-D reserves the right to seek damages from

any such person to the fullest extent permitted by law. DLSU-D's failure to enforce any term of these Official Rules and Regulations shall not constitute a waiver of that provision.

11. DLSU-D is not responsible for:

- a. any incorrect or inaccurate information, whether caused by raffle purchasers, printing errors or by any of the programming associated with or utilized in the raffle;
- b. technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines, internet connectivity or hard/software ;
- c. unauthorized human intervention in any part of the raffle process;
- d. technical or human error which may occur in the administration of the raffle or the processing of raffle ticket purchases; or
- e. any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from raffle purchaser's participation in the raffle or receipt or use or misuse of any prize. If for any reason a raffle ticket is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, a ticket purchaser's sole remedy is another ticket in the raffle, provided that if it is not possible to award another ticket due to discontinuance of the raffle, or any part of it, for any reason, DLSU-D, at its discretion, may elect to hold a random drawing from among all eligible raffle tickets up to the date of discontinuance for any or all of the prizes offered herein. No more than the stated number of prizes will be awarded.

12. Except where prohibited, raffle purchasers agree that:

- a. all disputes, claims and causes of action arising out of or connected with this raffle any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate Philippine Court;
- b. all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this raffle, but in no event attorneys' fees; and
- c. under no circumstances will raffle ticket purchasers be permitted to obtain awards for, and hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and DLSU-D in connection with the raffle, shall be governed by, and construed in accordance with, the laws of the Philippines without giving effect to any choice of law or conflict of law rules, which would cause the application of the laws of any jurisdiction other than the Philippines.
